

## Immunization Requirements

USC Upstate requires the following immunizations to take classes on campus. Students are required to submit their immunization records NO LATER than 10 days prior to orientation. Students with incomplete or missing immunization records will have a hold placed on their accounts, which will prevent them from dropping, adding or registering for classes.

**ALL STUDENTS:**

- **MMR (Measles, Mumps, Rubella):** MMR is a 2-shot series. Students MUST submit proof of 2 doses. If unable to provide documentation of 2 doses, an MMR Antibody Titer laboratory report must be submitted. If Titer proves negative, then two administrations of the vaccine are required.
- **Tdap Vaccine:** (TD and dTap DO NOT fulfill requirement)

**HRL RESIDENTS ONLY:**

- **MCV4 Meningococcal Vaccine:** At least one dose must have been administered AFTER the 16th birthday. This vaccine is only required for students living in campus housing.

**RECOMMENDED BUT NOT CURRENTLY REQUIRED:**

- COVID-19
- Meningitis B
- Influenza
- All Standard Childhood Vaccinations

## How to submit your Immunizations

To submit immunization records, log in to [www.uscupstate.edu/myhealth](http://www.uscupstate.edu/myhealth) using your USC Upstate email and password. Click on the Immunization Records Submission link to upload a picture or PDF of your records. Once you've uploaded your documents, the status will list Not Compliant but the Details will change to Awaiting Review. Once reviewed, your status will change to Compliant and Details to Satisfied. Please give five business days for review.

## Frequently Asked Questions

1. I do not have health insurance, where can I get my immunizations?

- If you are 18 years old or younger, you may qualify for a federal program called VFC (vaccines for children).
- Please walk in to Health Services from 1:00 – 4:00 pm during orientation or call Health Services at 864-503-5191 to see if you qualify for VFC.
- If you do not qualify for VFC, self-pay pricing for required vaccines is noted below:

MMR: \$100

Tdap: \$50

MMR Titers (bloodwork to show immunity): \$50

MCV4: \$150

| Age          | Health Insurance Coverage | Cost and Resources   |
|--------------|---------------------------|--|
| N/A          | Yes                       | Most insurance companies cover immunizations. A pharmacy or doctor’s office can bill your insurance. Health Services does not bill insurance for services or bill students for office visits, only procedures. |
| 18 and under | Uninsured or Medicaid     | May qualify for VFC, call Health Services or DHEC for an appointment.  |
| 19 and over  | No                        | Self-pay pricing available at Health Services.   |

2. I have health insurance – can I use it to get my immunizations?

Yes. Most insurance companies cover immunizations, but we would encourage you to call them to verify. If they do, you can go to any pharmacy to have that administered and they can bill your insurance directly.
